## Notes

- a) All berthing is subject to availability and all berthing fees are payable in advance. **Only Annual berthing agreements shall have an automatic right of renewal.**
- b) Berthing charges include Harbour Dues, access to marina facilities, potable fresh water and all other services as advertised in "Operating Rules for Berth Holders and Visitors" document. (A charge may be levied for use of other services).
- c) Berthing availability for multihull may be subject to a surcharge. Such surcharge will be at the discretion of the Management.
- d) All berthing agreements are subject to adequate insurance.
- e) Electricity shall be charged at a separate rate and shall be inclusive of VAT.
- f) No houseboat, or boat used for habitation, shall lie or remain in the Harbour.
- g) All berthing agreements are subject to the Dun Laoghaire Harbour Bye-Laws, copies of which are available on request.

## Declaration
